LOANER VEHICLE AGREEMENT
LOANERS ARE SMOKE FREE and PET FREE

THE RECIPIENT OF THIS LOANER CAR ACKNOWLEDGES THE FOLLOWING RESPONSIBILITIES AS THE EXPRESS CONDITIONS FOR THE USE AND OPERATION OF SAID LOANER CAR:

1. The "Recipient" is the customer seen in the Customer Information at the bottom of this document.
2. The Recipient's insurance coverage is primary and will be responsible for any and all damage and liability arising out of or in any way related to the used and operation of this Loaner Vehicle. This includes hit and run and any damage occurring while in the recipient's possession. The Recipient will have full liability and collision for loaner car coverage on their policy
3. The Recipient will be responsible for any and all deductibles and expenses not covered by his/her insurance at the time of accident or incident.
4. **THE RECIPIENT IS AT LEAST 21 YEARS OF AGE AND HOLDS A VALID DRIVER'S LICENSE.**
5. The Recipient agrees to pay a **REFUELING FEE** (Fuel and Labor to refuel the vehicle) if vehicle is not returned with a FULL TANK.
6. The Recipient hereby entirely assumes sole and absolute responsibility and liability for any damage to the vehicle described above and owned by Meister Werks, LLC. This includes any loss, expense, fee, smoke / pet odor removal and/or claim resulting from or relating to the operation of said vehicle while it is the Recipient's possession / control.
7. The Recipient hereby certifies they possess motor vehicle liability insurance coverage which complies with the State of Washington minimum liability and collision requirements for loaner cars, and is sufficient to provide primary first vehicular coverage against any and all losses, damages, expense, fee and/or claim and hereby agrees to indemnify and hold Meister Werks, LLC harmless from and against any and all losses, claims, damages, expenses and/or fees, including attorney's fees, related to Recipient's possession of said vehicle while it is in their possession or control. Meister Werks, LLC insurance is excess over any other collectible insurance.
8. The Recipient shall pay a penalty of **\$75.00** (seventy-five dollars) PER CALENDAR DAY, including weekends, that the Loaner Vehicle is kept, within 24-hours, after Meister Werks, LLC has advised in person, telephone call, voicemail, email or text message, that service on my vehicle has been completed. If the Recipient opts not to have any service performed by Meister Werks, the Recipient shall pay \$75.00 PER CALENDAR DAY for a vehicle rental fee.
9. The Recipient agrees to **pay any parking and /or toll violation fees** that are assigned to the vehicle when in my possession as well as a **\$25.00** research and processing fee.
10. If loaner vehicle is smoked in, The Recipient agrees to pay any and/or all cleaning
